HR's Elite

Who are the 40 highest-paid HR executives listed in SEC filings? And what did they earn?

For the third straight year, Dennis M. Donovan, executive vice president of HR at Home Depot, was the highest-paid HR executive listed in a database of Securities and Exchange Commission filings.

Donovan earned slightly less than \$6.4 million in 2004, compared to about \$5.3 million in 2003. The increase was roughly \$300,000 more than the increase reported a year before that.

Equilar Inc. of San Mateo, Calif., produces the ranking of the 40 highest-paid HR executives exclusively for *Human Resource Executive*. In all, 176 HR executives were among the five most highly compensated officers in their

companies and were therefore listed in the SEC filings of the Russell 3000 companies surveyed.

Donovan was the only HR executive to earn more than \$5 million in 2003. For 2004, however, he was joined by two other executives: Craig E. Schneider, executive vice president of HR for Biogen IDEC (roughly \$5.8 million), and Michael D'Ambrose, executive vice president of HR for First Data Corp. (roughly \$5.3 million).

Those mentioned in the latest SEC filings earned a median of roughly \$166 per employee. On the high end, Sandra Matrick Forman, general counsel, chief compliance officer and chief HR officer for Harris and Harris Group—a business development firm that employed just eight workers—received more than \$22,000 per employee. On the low end, Lea Soupata, senior vice president and HR group manager at United Parcel Service Inc., earned \$3.54 per employee. UPS employed 384,000 workers in 2004.

As a percentage of CEOs' total compensation, the HR executives earned a median of 28.5 percent. Ann L. McDaniel, vice president of human resources for the Washington Post Co., had the highest percent at around 215 percent of CEO pay, while Robyn T. Mingle, senior vice president of human resources at Hovnanian Enterprises, had the lowest at 1.5 percent.

HR executives with two years of data clearly did better in 2004 than those the year before. Compared with a modest decrease in 2003, the HR executives from the most recent SEC filings experienced an increase of 11.4 percent. John R. Stark, vice president of human resources, secretary and corporate counsel of Stillwater Mining, had the biggest increase—349.2 percent. C. Gabriel Haagensen, executive vice president of human capital management for Provident Financial Services Inc., experienced the biggest percentage decrease—roughly 91 percent.
